While we are doing everything we can to ensure the health and safety of all our guests, owners and employees, we can't do it alone. So we ask that you read and sign this BGV Shines Promise—a mutual agreement on our part and yours to abide by the steps required to keep us all safe, so that we can continue enjoying the unforgettable Breckenridge experiences that draw us here in the first place.

- 1. We will maintain a distance of six feet from anyone who is not a member of our travel party
- 2. We will practice frequent handwashing and hand sanitization
- 3. We will keep our faces covered in indoor areas open to the general public, or outdoors whenever six feet of separation cannot be maintained
- 4. We will limit direct contact with staff by calling or texting with any requests and/or questions
- 5. We understand that certain amenities/services will not be available and that other amenities/services will be available on a limited basis
- 6. We will take the stairs when going down if physically able to do so, in order to ensure that the elevators are available for those going up and/or those who are physically unable to take the stairs
- 7. We understand the contagious nature of COVID-19 and voluntarily assume the risk of exposure or infection
- 8. We will seek medical attention for any of the following symptoms: fever, cough, muscle aches, difficulty breathing, headache, or any other symptoms associated with COVID-19
- 9. We will return to our primary residence immediately if any member of our travel party tests positive for COVID-19
- 10. We will enjoy our vacation and allow staff to address any noncompliance issues with this promise

By signing this promise, I also confirm that neither myself nor anyone in my travel party has had a confirmed case of COVID-19 in the past 14 days, nor have we been in close contact with someone who has had a confirmed case of COVID-19 in the past 14 days. In addition, I also confirm that my travel party size does not exceed the maximum number of individuals allowed per code and is comprised of no more than one household per unit-key. I also understand that gatherings are limited to no more than one household, defined as those who currently reside together.
